Re: Mandatory Developmental Disabilities Provider Meeting

As you may know, the Department of Behavioral Health and Developmental Disabilities (DBHDD) is engaged in a settlement agreement with the U.S. Department of Justice (DOJ) that requires us to transition all individuals with developmental disabilities from state hospital settings into community placements. This mandate is aligned with DBHDD's vision for all people to live in the most appropriate setting, promoting integration and facilitating a life of recovery and independence.

Recently, the DOJ has expressed a deep concern about the state's compliance with the quality of community placements for individuals with developmental disabilities. As a state, we must do better. In response, we committed to the DOJ that we would convene all DD providers across Georgia to inform them of our expectations regarding the delivery of quality care in integrated settings, as well as our plans to increase oversight and accountability.

As such, a mandatory meeting for all DD providers will be held on Friday, March 15, 2013. At this meeting, the DBHDD leadership team will outline expectations and inform you of upcoming plans. We can only be successful if the state works in partnership with our provider network to achieve our common goals. The details of the mandatory meeting are as follows:
